

## ONLINE APPLICATION CHEAT SHEET

## **FINANCIAL VERIFICATION**

• Students must enter income information for their custodial parent who will then provide tax information that indicates the student as a dependent.

• If the parents do not file taxes they must submit letters of documentation that indicate other forms of assistance received.

• The picture below is from a previous year's application; the dates on the new application should read 2014 and 2015. Parents may estimate the values or use information from their 2013 and 2014 taxes if they do not receive this year's tax return prior to submitting the online application.
